IS OLD AGE TO EXPENSIVE WHEN DEALING WITH UNCLE SAM?

OUR SHERIFF WANTS IT ALL AND TO H--- WITH ALL OF US

It wasn't so long ago that Sheriff Doug Gillespie spoke before our group and made no bones about the fact that he will want the extra ¼% sales tax added for his use in the 2009 legislative session. Added to that he also thinks it would be best to consolidate all his needs into a brand new building of almost 400,000 square feet at a cost of several hundred millions. We have been through these ventures before in the Clark County stone castle which was told to us to be partially funded by money put away on the quite which means not telling the tax payers that when there was a budget balance (planned) surplus that was to be the beginning of that building funding and of course that \$25,000,000 ran out early so another equal amount had to be covered by the taxpayers by bonds. Then the Clark County University Trauma Center was going to be a real boondoggle until we got involved and convinced the County Commissioners to buy out the developer and finish it themselves. Because of oversight this time it worked. That is a problem with most government building projects where politicians or in this case a favored manager was allowed to get it started before it was found out he was doing a pretty shady deal that was going to mean millions for a couple of buddies that were wired by him to get the job. In this case they were given a contract to build the building on a lease/buy back that was going to put millions in their pockets with no risk because they had the county backing it up to rent for 25 or so years that made for easy financing in their case. I do not want to see any tricks like this played by our sheriff for his new monstrous building something on the order of about 350,000 sq. feet. These build lease back deals are a means to make millionaires out of the developer/builder type contract. I even question the wisdom of putting so much bureaucracy in one building. In this day and age of electronic communications it might be worth thinking more about spread out management with a small administrative management team in a much smaller building. This might not make for a smaller main building in the end but a more effective way to manage the services better. I hope there is a lot of give and take on the best planning before brick and mortar are put in place. As far as the sheriff wanting the next ¼% sales tax increase for more cops that I believe is something that should be put off until at least the next session of the legislature in 2011 given how our economy has tanked. Another fact is that quite a few thousand people are leaving the area because of the fall off of the construction boom and won't pick up in the foreseeable future. Also with a couple of years breather why not give the present sales tax time to work before taxing the taxpayers for more money. My thinking is that for every ¼% we take \$60 to \$80 million out of our purchasing power each year the sales tax increase is a burden on everyone's back. This definitely is not the time to increase any sales tax for anything and on anyone. If the sheriff really wants to help earn that increase may I suggest we all get together in Clark County and have the Clark County Water Authority turn back its sales tax to the taxpayers? If we can do that in the next session or two then I say think about the sheriff getting some of it if the economy is better. I often wonder why politicians can never leave their fingers off of money no matter how bad the economy is. If the sheriff will think back when his sales tax was voted in for two increments the economy was so much better than it is now and there is no sign that our economy is going to get better soon so sheriff how about you tighten your belt a bit like all of the rest of us.

LAST BUT NOT LEAST THE GOVERNOR IS RIGHT "NO NEW TAXES"

Like the other comments doesn't the same go for our state legislature NO NEW TAXES? With the economy in the tank there should be no question that our state budget must be cut in order to live within our present economic period. That means cutting the budget not increasing taxes. We should be very happy that our state is doing as well as it is, so I say again do the right thing cut back expenses and hold the line for 2009 to 2011.

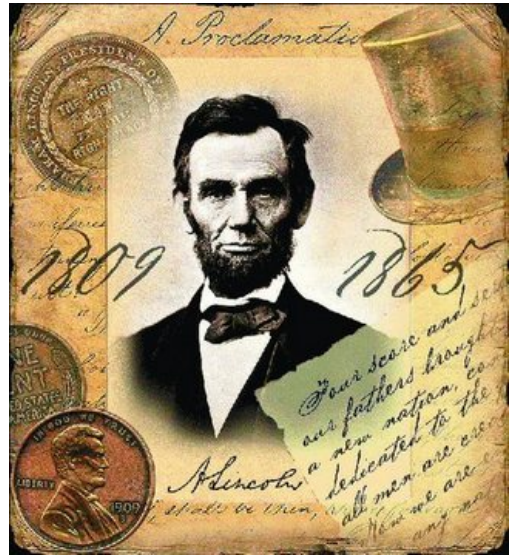
President of the United States, April 30, 1789 to March 4, 1797

- ◆ Born February 22, 1732, Died December 14, 1799
- ◆ Age at Death: 67
- ◆ Place of Burial: Mount Vernon, Virginia
- ◆ Only President to be elected unanimously
- ◆ Only President inaugurated in 2 cities - New York and Philadelphia
- ◆ He was the only President that did not live in the White House. He was involved in the planning of the Capitol.
- ◆ Washington did his own bookkeeping and recorded every penny of expense or profit. His ledgers still exist today.
- ◆ There were 13 stars on the United States flag when Washington became President in 1789.
- ◆ Five states were added to the Union during Washington's presidency - North Carolina (1789), Rhode Island (1790), Vermont (1791), Kentucky (1792), and Tennessee (1796).
- ◆ The last flag Washington served under was the famous **Star Spangled Banner** which had the 15 star and 15 stripe design which was used until 1818.

Illegal immigrants are a factor in California's budget math

From Sacramento — Based on my e-mail, a lot of folks think the solution to California's state budget deficit is to round up all the illegal immigrants and truck them down to Mexico.

Wrong. Even if it were logistically possible and the deportees didn't just climb off the truck and hitch another ride back up north, their absence from the state wouldn't come close to saving enough tax dollars to balance a budget that has a \$42-billion hole projected over the next 17 months.

Painful cuts in education, healthcare and social service programs still would be needed. Sharp tax increases would be required. That said, let's be honest: Illegal immigration does cost California taxpayers a substantial wad, undeniably into the billions. But it hasn't been PC for officeholders to talk about this for years, ever since Gov. Pete Wilson broke his pick waging an aggressive campaign for Proposition 187. That 1994 ballot initiative sought to bar illegal immigrants from most public services, including education. Voters approved the measure overwhelmingly, but it was tossed out by the courts.

Wilson was demonized by Democrats within the Latino community. And many think the Republican Party never has recovered among this rapidly growing slice of the electorate.

So it's not a topic that comes easily to the tongues of politicians, even Republicans.

Besides, most of the policy issues are out of California's hands. The federal government has jurisdiction over the border. Federal law decrees that every child is entitled to attend public school, regardless of immigration status. And every person -- here illegally or not -- must be cared for in hospital emergency rooms.

But the state does add a few benefits that aren't required.

And as Gov. Arnold Schwarzenegger and legislative leaders dig into the books trying to find billions in savings, at least a brief look at what's being spent on illegal immigrants seems in order.

First, nobody seems to know exactly. Numbers vary widely, depending which side they come from in the ongoing angry debate over whether people who entered the country illegally to work should be allowed to stay or loaded on the southbound truck.

But here are some no-agenda numbers:

* There were 2.8 million illegal immigrants living in California in 2006, the last year for which there are relatively good figures, according to the nonpartisan Public Policy Institute of California. That represented about 8% of the state's population and roughly a quarter of the nation's illegal immigrants. About 90% of California's illegal immigrants were from Latin America; 65% from Mexico.

* There are roughly 19,000 illegal immigrants in state prisons, representing 11% of all inmates. That's costing \$970 million during the current fiscal year. The feds kick in a measly \$111 million, leaving the state with an \$859 million tab.

* Schools are the toughest to calculate. Administrators don't ask kids about citizenship status. Anyway, many children of illegal immigrants were born in this country and automatically became U.S. citizens.

If you figure that the children of illegal immigrants attending K-12 schools approximate the proportion of illegal immigrants in the population, the bill currently comes to roughly \$4 billion. Most is state money; some local property taxes.

* Illegal immigrants aren't entitled to welfare, called CalWORKs. But their citizen children are. Roughly 190,000 kids are receiving welfare checks that pass through their parents. The cost: about \$500 million, according to the nonpartisan Legislative Analyst's Office.

Schwarzenegger has proposed removing these children from the welfare rolls after five years. It's part of a broader proposal to also boot off, after five years, the children of U.S. citizens who aren't meeting federal work requirements. There'd be a combined savings of \$522 million.

* The state is spending \$775 million on Medi-Cal healthcare for illegal immigrants, according to the legislative analyst. Of that, \$642 million goes into direct benefits. Practically all the rest is paid to counties to administer the program. The feds generally match the state dollar-for-dollar on mandatory programs.

So-called emergency services are the biggest state cost: \$536 million. Prenatal care is \$59 million. Not counted in the overall total is the cost of baby delivery -- \$108 million -- because the newborns aren't illegal immigrants.

The state also pays \$47 million for programs that Washington does not require: Non-emergency care (breast and cervical cancer treatment), \$25 million; long-term nursing home care, \$19 million; abortions, \$3 million.

Schwarzenegger has proposed requiring illegal immigrants to requalify every month for Medi-Cal benefits, except pregnancy-related emergencies.

There also are other taxpayer costs -- especially through local governments -- but those are the biggies for the state. Add them all up and the state spends well over \$5 billion a year on illegal immigrants and their families.

Of course, illegal immigrants do pay state taxes. But no way do they pay enough to replenish what they're drawing in services. Their main revenue contribution would be the sales tax, but they can't afford to be big consumers, and food and prescription drugs are exempt.

My view is this: These people are here illegally and shouldn't be, regardless of whether they're just looking for a better life. Do it the legal way. And enforce the law against hiring the undocumented. On the other hand, they are here. We can't have uneducated kids and unhealthy people living with us. We have moral obligations and practical imperatives.

ABRAHAM LINCOLN TRIVIA

- ♣ Abraham Lincoln was the first president to have a beard while in office. He grew his beard at the suggestion of an 11 year old girl.
- ♣ Lincoln, Nebraska was named after Abraham Lincoln.
- ♣ Abe Lincoln's mother, Nancy Hanks Lincoln, died when the family dairy cow ate poisonous mushrooms and she drank the milk.
- ♣ A plot was developed to steal Lincoln's body, so a secret society was formed to guard his tomb.
- ♣ During the Civil War, telegraph wires were strung to follow the action on the battlefield. But there was no telegraph office in the White House, so Lincoln went across the street to the War Department to get the news.
- ♣ Lincoln was the tallest president. He was 6 feet and four inches tall.
- ♣ Lincoln once had a dream right before the fall of Richmond that he would die. He dreamt that he was in the White House, he heard crying and when he found the room it was coming from he asked who had died. The man said the President. He looked in the coffin and saw his own face. A week later, Lincoln died.
- ♣ Lincoln was shot on Good Friday.
- ♣ Robert Todd Lincoln arrived too late to stop three separate presidential assassinations. He met his father, President Abraham Lincoln, at the theatre after John Wilkes Booth had fired the shot. He went to a Washington train station to meet President Garfield, arriving only minutes after he was shot. And, he traveled to Buffalo, New York to meet President McKinley, but got there after the fatal shot had already been fired.
- ♣ Lincoln had a cat named "Bob," a turkey named "Jack," and a dog named "Jib."
- ♣ He was the first president to be photographed at his inauguration. John Wilkes Booth (his assassin) can be seen standing close to Lincoln in the picture.
- ♣ Lincoln was the only president to receive a patent, for a device for lifting boats over shoals.
- ♣ Lincoln's brother, half-brothers, and brothers-in-law fought in the Confederate Army.
- ♣ Abraham Lincoln was shot while watching a performance of Our American Cousin at Ford's Theatre in Washington, D.C. The same play was also running at the Maverick Theatre in Chicago on May 18, 1860, the day Lincoln was nominated for president in that city.
- ♣ Lincoln's favorite sport was wrestling.
- ♣ Lincoln worked as a deck hand on a Mississippi flatboat.
- ♣ Lincoln had a substitute fight for him during the Civil War. Not a paid substitute as some might think. When J. Summerfield Staples, the son of an army chaplain, heard that Lincoln felt that the president should be fighting in the war (but couldn't because of all his duties), Staples volunteered to fight as a substitute. Both he and his father survived through the war, and returned home to Stroudsburg, Pennsylvania. If one traveled to the cemetery there, they would find a headstone that reads: J. Summerfield Staples, A private of Co. C176 Reg. P.V., Also a member of the 2, Reg. D.C. Vol., A substitute for Abraham Lincoln. Died Jan. 11, 1888, Age 43 yrs,-4 mos. & 27 days
- ♣ Lincoln had a wart on his right cheek, a scar on his thumb from an ax accident, and a scar over his right eye from a fight with a gang of thieves.
- ♣ John Wilkes Booth's brother once saved Abraham Lincoln's son's life.
- ♣ The contents of his pockets on the night of his assassination weren't revealed until February 12, 1976. They contained two pairs of spectacles, a chamois lens cleaner, an ivory and silver pocketknife, a large white Irish linen handkerchief, slightly used, with "A. Lincoln" embroidered in red, a gold quartz watch fob without a watch, a new silk-lined, leather wallet containing a pencil, a Confederate five-dollar bill, and news clippings of unrest in the Confederate army, emancipation in Missouri, the Union party platform of 1864, and an article on the presidency by John Bright.
- ♣ He was named after his grandfather.
- ♣ Lincoln and his wife held séances in the White House. They had great interest in psychic phenomena.
- ♣ Lincoln loved the works of Edgar Allan Poe.
- ♣ Abraham Lincoln was the first president to be born outside of the original thirteen colonies. He was born in Kentucky.

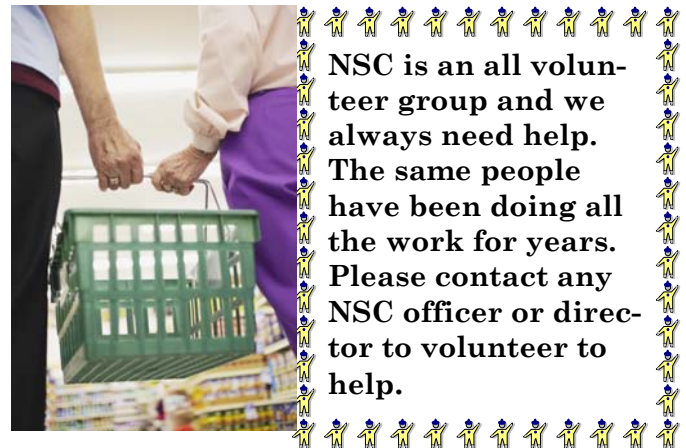

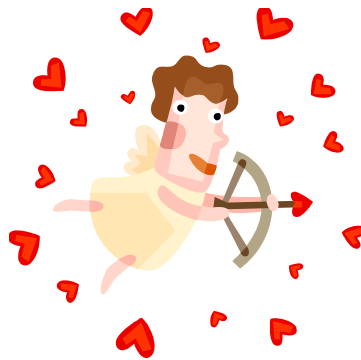

Rommel in Africa

On this day, German General Erwin Rommel, with the newly formed Afrika Korps, arrives in Tripoli, Libya to reinforce the beleaguered Italians' position.

Adolf Hitler established the Afrika Korps, in January 1941, for the explicit purpose of helping his Italian Axis partner maintain territorial gains in North Africa. The Fuhrer declared, "For strategic, political, and psychological reasons, Germany must assist Italy in Africa". In three months, the British had pushed the Italians out of Egypt while wounding or killing 20,000 Italian soldiers and taking another 130,000 prisoner. General Rommel was dispatched to Libya along with the new Afrika Korps to take control of the deteriorating situation. Up until that time, Italian General Ettore Bastico was the overall commander of the Axis forces in North Africa--which included a German panzer division and the Italian armored division. Rommel was supposed to command only his Afrika Korps and an Italian corps in Libya, but wound up running the entire North African campaign.

The German soldiers of the Afrika Korps found adapting to the desert climate very difficult; Rommel found commanding his Italian troops, who had been used to an Italian commander, difficult as well. When Hitler, finally gave the go-ahead for an offensive against British positions in Egypt (he was preoccupied with his plans for the invasion of the Soviet Union), Rommel's forces were stopped dead in their tracks and then forced to retreat. In the famous battle of El Alamein, the British Eighth Army--beginning in October 23, 1942--surprised the German commander with its brute resolve, and pushed him and his Afrika Korps back across and out of North Africa. Rommel finally withdrew from North Africa entirely and returned to Europe in March of 1943, leaving the Afrika Korps in other hands.
