651,000 jobs cut in February – Reid, Pelosi, Obama & Chamber of Commerce insist on importing more foreign workers

Another month has passed. Another half-million (or more) jobs have been lost. And our federal leaders continue to do nothing about auto-pilot programs that are flooding our country with foreign workers.

Nothing has changed since last year when 138,000 new foreign workers were added to the U.S. each month on average.

Here are the latest government facts that can't seem to soften the hardened hearts of our leaders

The official unemployment rate has soared to 8.1% (highest since 1983)

U.S. employers cut 651,000 jobs in February

That is on top of 655,000 jobs lost in January and 681,000 jobs cut in December.

4.4 million -- Total jobs eliminated since the recession began in December of 2007.

The number of Americans reeling from the bad job market is staggering:

12.5 million Americans are actively looking for a job and cannot find even part-time employment.

Another 8.6 million Americans want a full-time job and have been forced to work part-time.

American workers in nearly every part of the economy were under seige in February:

Construction companies cut 104,000 jobs.

Factories cut 168,000.

Retailers cut nearly 40,000.

Professional and business services cut 180,000, with 78,000 jobs lost at temporary-help agencies.

Financial companies cut 44,000 jobs.

Leisure and hospitality firms chopped 33,000 positions.

BUT FEDERAL LEADERS SAY MORE FOREIGN WORKERS NEEDED

Following the lead of the U.S. Chamber of Commerce, Pres. Obama, Senate Majority Leader Reid and House Speaker Pelosi refuse to respond to the plight of unemployed American workers and consider a suspension of most immigration and foreign worker programs.

We at NumbersUSA have said since November that the national jobs disaster requires an immediate suspension of all immigration and temporary foreign work programs except for spouses and minor children of U.S. citizens, a controlled number of emergency refugees and a few thousand truly extraordinary skilled workers for whom no American substitute is available.

With no sign of federal leaders tightening the flow, another approximately 280,000 foreign workers have been allowed to enter U.S. job markets since the first of this year alone.

Not only that, but the leaders have continued to try to protect as many U.S. jobs as possible for illegal aliens. Sen. Reid until today has refused to even allow a vote on a 5-year extension of a VOLUNTARY E-Verify program that allows businesses to make sure jobs go to legal workers.

And in the nation's top newspapers, such as the New York Times and Washington Post, ivory tower editorial writers are continuing to argue that we need more foreign workers in order to turn our economy around!

I wish they and our political leaders could have a chance to say that while looking in the eyes of the 12.5 million officially unemployed Americans.

Notch Fairness Act of 2009

S. 81:

111th Congress: This is a bill in the U.S. Congress originating in the Senate ("S."). A bill must be passed by both the Senate and House and then be signed by the President before it becomes law.

Bill numbers restart from 1 every two years. Each two-year cycle is called a session of Congress. This bill was created in the 111th Congress, in 2009-2010.

2009-2010 Notch Fairness Act of 2009

A bill to amend title II of the Social Security Act to allow workers who attain age 65 after 1981 and before 1992 to choose either lump sum payments over **four years** totaling \$5,000 or an improved benefit computation formula under a new 10-year rule governing the transition to the changes in benefit computation rules enacted in the Social Security Amendments of 1977, and for other purposes.

H.R. 1067:

111st Congress: This is a bill in the U.S. Congress originating in the House of Representatives ("H.R."). A bill must be passed by both the House and Senate and then be signed by the President before it becomes law.

2009-2010 Notch Fairness Act of 2009

To amend title II of the Social Security Act to allow workers who attain age 65 after 1981 and before 1992 to choose either lump sum payments over **four years** totaling \$5,000 or an improved benefit computation formula under a new 10-year rule governing the transition to the changes in benefit computation rules enacted in the Social Security Amendments of 1977, and for other purposes.

Isn't it strange that the stimulus bill passed by Congress and signed into law by President Obama makes provision to pay Filipino veterans who fought in WWII, mostly as guerrilla fighters, \$15,000 if they are American citizens and \$9,000 for non-citizens but still ignores the Notch Babies, most of whom are also veterans of WWII. As shown above, bills have been introduced since 1996 to give the Babies \$5,000 in a way that most of them will be dead before they can collect it. It seems to me that they could have been included in the stimulus package and paid a lump sum.

The Filipinos went through a similar procedure before finally being granted their money. In 1942 President Roosevelt classified the Filipino fighters as veterans of the United States military with full benefits, however in 1946 Congress took away the citizenship and veterans' benefits saving an estimated \$57 billion (470,000 originally volunteered). More than 60 years have passed and the average age of the fighters is 90. The benefits can't be passed on to wives or other family members, so they have to hurry to get it before they are no longer with us. \$198 million has been allocated based on 18,000 veterans still being alive. So far more than 20,000 have applied and, while about 10 are dying each day, the list is growing.

If you want to help the Notch Babies (many NSC members qualify) contact your Congress people and insist they do something to give these people the pittance that has been denied to them for so long – before it is too late. Vern
